These serve as a driving force for economic development, acting as an alternative source of revenue outside other sectors. We will address some key concepts related to tourism and its most important components.

#### **Definition of Tourism:**

Tourism refers to:

"A set of phenomena and activities resulting from the travel and stay of people in a country other than their own for a limited period, without engaging in commercial or gainful activity or permanent residence."

## As per researcher **Marcel Hunziker**:

"Tourism is the set of relationships and phenomena arising from the travel and temporary stay of a person outside their usual place of residence, as long as the stay is temporary and not related to gainful employment." (Akram, 2018, p. 131)

## Types of Tourism:

- **Recreational Tourism:** Enjoyment of natural sceneries like beaches, forests, and mountains.
- **Medical Tourism:** Focused on treatment and healthcare.
- Cultural Tourism: Discovering and exchanging cultures.
- **Social Tourism:** Visiting relatives.
- **Religious Tourism:** Visiting places of worship.

# Importance of the Tourism Sector:

The tourism sector holds great importance, including the following:

Increasing social welfare by providing additional financial revenues.

Reducing rural migration and improving rural areas.

Narrowing the gap between rural and urban regions.

Focusing on rural areas and recognizing their value as an additional economic force

Increasing the Gross Domestic Product (GDP).

### **Indirect Economic Effects of Tourism:**

The tourism sector has indirect economic effects, including:

## • Marketing certain goods:

This includes tourists' purchases of souvenirs or artifacts, as well as the use of certain historical sites. This type of spending is considered a form of export of national products without the need for foreign marketing.

## • Improving the quality of facilities and infrastructure:

In order to attract the largest possible number of tourists, countries must develop roads, facilities, and spaces that serve as attractions for visitors.

## • Increasing national and foreign investment:

Investment is reflected in the quality of hotels, restaurants, sports centers, and tourist villages, which in turn stimulates other sectors such as agriculture and services through increased demand for their products.

# • Improving the balance of payments:

This occurs through the flow of capital into tourism-related projects, which contributes to increasing the national income directly or indirectly. (Akram, 2018, pp. 131–133)

## Social Impacts of Tourism:

We observe that the more attention is given to the tourism sector, the more the wheel of economic development turns, leading to improvements in the social aspect through increased capital, higher employment rates, and an improved standard of living. Among the most important social impacts of tourism are:

- Increasing employment rates and solving the problem of unemployment.
- Achieving social welfare. (Akram, 2018, p. 133)

## Concept of Economic Development:

We see that the tourism sector plays a major role in the economies of countries. It has become an important part of economic policies due to its role in driving and boosting the pace of economic development, and in making the economy characterized by a degree of diversification. It has become an industrial sector because of its impact on the economy through tourism spending, as tourists stay for a certain period in a country, which allows the inflow of foreign currency and reduces unemployment.

Economic development is "considered the process through which an increase in the average real income per capita is achieved."

It is also "the process directed towards creating transformations in the economic and social structure; it is capable of revitalizing productive capacities, supported by efforts aimed at achieving an organized increase in the average real income per capita in the foreseeable future. It seeks to provide the essential needs of the individual and ensure their right to participate in deepening the requirements of security and stability in the long term" (Belqaz and others, 2019, p. 184).

- Contributing to the Gross Domestic Product (GDP).
- Increasing foreign currency earnings as a result of selling tourism services.
- Revitalizing some areas that have natural tourist attractions but are deprived of development.
- Contributing to improving the trade balance.
- Raising the standard of living and increasing the social welfare of the population.
- Increasing economic activity related to tourism in the incomes of households and individuals.
- Enhancing opportunities for national and foreign investment and stimulating tourism.
- Achieving economic prosperity, meaning that the funds entering the tourism sector circulate within the national economy through an increase in foreign currency, which reflects positively on the economic cycle.

## Tourism's Impact on Egypt's GDP:

The effects of tourism on the Egyptian national output appear through: (Noor Al-Huda, 2015, p. 471)

Tourism contributes to the shift from some traditional activities in the economic structure of society, such as the shift from industry, fishing, agriculture, and mining activities to tourism as a transformative industry, thus increasing the national output.

The shift to rural tourism changes the pattern of resource and land use by improving transportation networks, electricity, water, and establishing rural resorts and hotels.

Tourism consumption is considered a new economic force as it contributes to the increase in overall consumption in other sectors, thereby increasing national income.

Tourism demand is considered an added value and leads to real growth in national income through an interactive dynamic.

## Opportunities for Tourism in Egypt:

The Arab Republic of Egypt has many tourism opportunities that make it a global tourist hub due to its rich cultural heritage. We highlight the following:

### **Cultural Tourism:**

Egypt represents a rich cultural heritage through its historical legacy of monuments, temples, pyramids, and museums dating back to ancient times, which continue to attract tourists and scholars, making it a fertile land for exploration.

## **Natural Tourism:**

Egypt features a vast geographical mix including the sea, the Sinai Desert, the Suez Canal, expansive deserts, beautiful beaches, and resorts to enjoy nature.

## Religious Tourism:

Egypt is a religious destination for students of knowledge worldwide, as it is a blend of religions (Islam, Christianity, Judaism), which helps attract tourists. Notable religious sites include mosques like Al-Azhar Mosque and churches significant to Christians.

## Health and Therapeutic Tourism:

Due to its geographic location and mild climate in some regions, Egypt can utilize thermal waters for natural treatments by offering relaxation services and benefiting from traditional therapies such as mud treatments and baths.

## Marine, Sports, and Adventure Tourism:

Egypt exploits activities like diving, surfing, mountain climbing, mountain biking, as well as marine trips and surfing sports.

## Nile Tourism:

The Nile River, which extends for 6,700 km, is used for boat rides to enjoy the stunning scenery and enchanting Nile cruises.

Despite Egypt's abundance of diverse tourism resources that make it one of the leading countries in tourism, it still suffers from instability in its entrances due to the lack of political stability.

We observe from Table No. (01) that there was an increase in the contribution of tourism sector revenues to the Gross Domestic Product (GDP), as the revenue percentage rose from 4.22% to 8.9% between the years 2002 and 2007. However, this percentage declined in the years 2008 and 2009 due to the impact of the global economic crisis that hit the world in 2008. The percentage also decreased in 2010 as a result of the effects of the revolution during January 2011, which negatively impacted the GDP.

Through Table No. (02), which illustrates the number of tourists and the nights they spent in the Arab Republic of Egypt from the period 2000 to 2015, we observe that the number of tourists was on a steady rise from the year 2000 to 2011. In 2000, the number of tourists was estimated at 4.3 million, increasing to 14.7 million by 2010. The number of nights booked during the same period also rose from 32.8 million to 147.4 million nights. This reflects the flourishing of the tourism sector during that period, which experienced both tourism and social stability, positively impacting the tourism industry.

However, from 2011 onwards, the tourism sector saw a decline due to political instability during the January 2011 revolution, which led to a decrease in the number of tourists.

From Table No. (03), we observe a rise in tourism revenue from 2001 to 2010, increasing from \$4.119 billion to \$13.233 billion. This is a result of political stability in the Arab Republic of Egypt, which positively affected the tourism sector. In 2011, however, there is a noticeable decline — from \$9.33 billion in 2011 to \$9.500 billion in 2013. This drop is attributed to the political and social instability in the Arab Republic of Egypt.

#### Conclusion

Tourism significantly supports economic development in Egypt. Despite various challenges—mainly political instability—the government continues to invest heavily in this vital sector, encouraging both local and foreign investment.
